The LEED (Leadership in Energy and Environmental Design) Green Building Rating System® is a voluntary, consensus-based national standard for developing high-performance, sustainable buildings. USGBC's members, representing every sector of the building industry, developed and continue to refine LEED.

4.2 <b>Recycled Content:</b> 20%, (sum of post-consumer + 1/2 pre-consumer)	Increase demand for building products that incorporate recycled materials, thereby reducing demand for processing of new virgin materials
5.1 <b>Regional Materials:</b> 10% (final assembly done regionally)	Increase demand for building materials and products that are extracted and manufactured within the region, (500 miles of project site) thereby supporting the use of indigenous resources and reducing the environmental impacts resulting from transportation.
5.2 <b>Regional Materials:</b> 20% (final assembly and harvest, extraction point done regionally)	Increase demand for building materials and products that are extracted and manufactured within the region, (500 miles of project site) thereby supporting the use of indigenous resources and reducing the environmental impacts resulting from transportation.
<b>6 Rapidly Renewable Material</b>	Reduce the use and depletion of finite raw materials and long-cycle renewable materials by replacing them with rapidly renewable materials.
